After patiently waiting for 2 and a half weeks for the remnants of cyclone Gita to pass we saw a weather window. The forecast wasn't great, but there was a chance that later in the week we would have a better window to travel from Lord Howe to New Zealand. We decided to depart Southport Queensland on the 24th of February to head to Lord Howe Island.

As we crossed the Gold Coast seaway the conditions weren't to bad, however as we got further out to sea, conditions worsened. We had 31 knot winds and seas 2.5 to 3 meters.

The seas weren't any worse than what we had experienced on the cabbage patch before, but the difference this time was that we were carrying an extra 3000L of fuel and we had 30 hours of driving ahead of us. We would have had enough fuel to get to Lord Howe without carrying any extra, but never having used bladders before we thought we would trial it on the shorter trip - and at \$3 per litre on Lord Howe it was the obvious decision!



The sun was setting and conditions were not any better. The boat was rolling side to side and I was watching the bladders through the camera at the helm. I decided to check the bladders before dark, I woke up Gabriella, put a life vest on and went outside. Lucky I did! With all the roll and spray we were copping the bladders had loosened, one of the straps was actually tearing. I tighten the straps and added extra straps for security.

Around 11pm the sea started to calm, and as the night progressed the seas got calmer and calmer.

After 31 hours at sea we had arrived at Lord Howe Island. We radioed the harbour master to advise him of our arrival and he helped us navigate through the reefs and shallow water to get to our mooring.

Wow - Lord Howe island was truely an amazing place!

Its sandy beaches, subtropical forest and crystal clear waters were a magical sight. We spent 3 days exploring the island, and it was shame we couldn't stay any long, but the weather was looking good to depart. It was time to fuel up and get the boat ready!

Refueling was not easy as once again we had to navigate through the shallow waters and reefs to get to the wharf.

The second part of voyage began peacefully. We operated 6 hour watches, conducted a safety check every 2 hours and we always ate together.





At night we had the light of the full moon reflecting off the sea and in the morning the sun rises were truely amazing.

We were about half way across and it had been smooth sailing so I decided to transfer the fuel. The transfer pump is directly connected into the tanks so this was a very easy process.

We had traveled 600nm and apart from being tired we were feeling confident with the remaining 200nm. As we approached 3 King islands the conditions were near perfect. The islands are only 33nm north west of New Zealands northern tip - this is where the South Pacific Ocean and the Tasman sea converge.

We were advised that the seas could be extremely treacherous here but we got lucky.

As we cruised past the islands watching the sunset and admiring her beauty, things started to turn for the worst. I was facing 3 to 4 meter seas and the most vertical waves I had ever seen. The boat was handling the conditions well however, I was not. I was feeling lethargic, sea sick and I couldn't take 6 more hours of it through the night. I decided to change course and steer to an anchorage I had found on the chart called Hoopers Point. After arriving at the anchorage the next challenge was to try find a safe place to anchor. I navigated carefully using the search light to locate the 2 drying reefs. I tucked in as close as I could but we still had a reasonable swell rolling us around. It was midnight and I was exhausted, at that point it was good enough. I dropped the anchor, maintained a watch for about 1 hour and then fell asleep.

We woke early the next morning eager to finish the last 100nm. Weather conditions were only slightly better but after a good nights sleep we were feeling refreshed.

We arrived at our final destination Opua in the early afternoon, cleared customs and had a much deserved drink to celebrate our safe arrival to New Zealand!

# 59th HIBT Kona Hawaii 2018

#### Team John Johnston, Game Fishing Club of S.A. just returned from the HIBT in Kona Hawaii.

The Team, Rolf Czabayski, Ralph Czabayski and Steve Morris left Adelaide on the 04/08/18 for Kona Hawaii to take part in the Hawaiian International Billfish Tournament. Fishing started at 8am on the 6th of August, Twenty-four teams comprised of many of the world's most competitive big game anglers boarded Kona's impressive sport fishing fleet and headed to the start line across Kailua Bay as day one of the 59th Hawaiian International Billfish Tournament went underway, at precisely 8am, following a traditional Hawaiian blessing.

HIBT Tournament control radioed, "Start fishing, Start fishing, Start Fishing



"signalling the teams to head out for five consecutive days of Kona Fishing. Anglers from Africa, Australia, Japan, New Caledonia, New Zealand, Papua New Guinea and the US Team's dropped their lines into Kona's famous fishing grounds, just after lunch Ralph junior was on strike when the line on the outrigger clip ignited from this clip and Ralph quickly lifted the rod out of the gunnel and made his way to the game chair where we successfully tagged and released



(after approx 10 minutes fight) his first Blue Marlin for the team. No more fish were hooked on day one. After returning to the harbour, all the tackle was checked by the judges. Line was to be measured for line class, lengths of double and leader and lure were measured. After all this, Ralph got his photo taken with Miss Marlin and the team. We were on the board with 300 points on day one. Top team was Moreton Bay Game Fishing Club with 2 Blue Marlin released and one short nose spearfish. We were in 4th place on day one.



**On day two**, after patrolling the Kona Coast up and down in the morning, we did not get a single strike. But around 2pm it was my time for the next hour to take any strike, the centre rigger left the rigger clip and the Shimano reel had a blistering welcoming sound, only to find out after a reasonable short fight it was a yellowfin tuna of 117.8 pounds on 24 kg line.

Tuna do not count to points towards the Billfish score but there is a separate Ahi section.



But listening to the ships radio, a few other boats had hook-ups on marlin. After returning to the harbour, we went to the shouting tent to verge our bad day with one or two whiskies, bourbon and bacardi.

We are now in 7th place.





On day Three, it started well with your truly hooking up on a Blue Marlin, jumping all over the place and violently checking if it could lose the hook but luckily, he was well hooked. 8 minutes later the fish was tagged and released. Ralph purchased a satellite tag to put in to a Blue Marlin which we had on board but decided not to put it in this Marlin as it was only 125 Pounds, but in very good condition. We got back on the board with another 300 points. This brought us back 4th place.

On Day Four, again, we trolled all day up and down the coast with no strike despite us putting in a lot of effort and going through a lot of lure changes.



On the end of the day, which played difficult to us, we ended on up on 5th place.

On the 5<sup>th</sup> and final day, the morning started well with tagging of Blue Marlin and capturing of Ahi but not on our boat, still no Billfish Only about one hour and twenty five minutes to go before the end of the tournament fishing time and suddenly a big bang from the left long rigger and we saw a nice Blue Marlin jumping in the distance. Before Steve got to the rod, we all got very excited because this could be the winning fish. We still had the Satellite Tag to put on a Marlin.

After a hard fight, Steve had the Blue marlin along site of the boat in tagging distance and soon after the marlin was tagged, we quickly decided to place the Satellite Tag on this estimated 200 pound Blue Marlin as there was only a short time left before the end of the tournament. We were hoping the Marlin will swim the longest distance in 89 Days, before the tag releases itself, so that Ralph, who purchased this Satellite Tag, will receive a free Entry for the next 60<sup>th</sup> anniversary tournament for the team he select.



We were back in 4th position out of 24 Teams on count back, with both teams on 900 points. The other team caught their first Marlin on day one in the morning and we caught our Marlin in the afternoon, this is why we missed out on the third place.

I'd like to take this opportunity to thank John Johnston for sending the team again from our club to the HIBT in Kona Hawaii to compete with the worlds best.

It has definitely opened a door to a whole new world in my Angling personally and I'm finding it all a very exciting challenge.

I am mainly a Land based angler, and I have to admit, I do love my freshwater fishing as well as saltwater. So in late April I decided to tackle my local freshwater venue, and have a crack at some ultra light line carp fishing.

I have never used lines as light as I am now before in my fishing and I'd be lying if i said it didn't take some getting used to. It did take a few trips to get a feel for it, but before long, I was consistently catching decent numbers of Carp.

I have to say I really do enjoy fishing with ultra light mono, you cant just "winch them in", its a challenge, and a fun

battle!

I did get absolutely smoked by a few fish, fish I just could not stop, and busted me off on structure, Ahh! The fish that get away.

My heaviest for the season went 8.60kg, caught on 2kg IGFA mono. A fantastic battle on ultra light line land based, and to be honest, a battle. I did not think I was going to win, netted on the 5th attempt, the fish just did not want to give up.

I knew this fish was the heaviest carp I'd ever caught on 2kg line, and I knew it could be in with a chance for a GFAA State record and maybe a National one as well.

Club member Jerry Burtt gave me a hand weighing and measuring the fish, and his skills with a camera are great. Jerry informed me that the fish was a GFAA, S.A. state record, and also an Australian record, on 2kg. I was very happy, a nice achievement for any land based Angler.






It would not been possible without Zane Niblock, Graham Bald, Paul Tobin, Scott Sinclair, Jerry Burt, Steve Morris, Geoff Harris, Oscar Dade, Nigel Hunt, Craig Dade, Ashley Brandom, Sam Roccatti and Bart Van der Heiden.

We started with the first recording of the season with Galaxy Star in August 2017. I have taken my 50ft Bertram to Robe in SA, the marina is very good and I leased a berth from the council for a 3 month period. I did a number of trips where we caught a few tuna but nothing to brag about as the big tuna avoided this area (Point score was only 800 for tagging) and Galaxy Star went back to the RSAYS.



In my other Boat, Broadbill, I have been fishing the waters off Port Lincoln where Broadbill is stationed and did the first trip in December 2017 for Eagle Rays and other species to Neptune Island.

January 2018, we went to Thistle Island and the Neptune Island for the first tuna and kingfish.





In March, the "Cabbage Patch" started to fire up with tuna, but all very small from 6-14 kg. So we fished light line, 3-6kg to gain some points. I also did a trip for Broadbill to the shelf, off Rocky Island, a long way from Port Lincoln with no success.


April we fished the Clubs Peter Teakle Port Lincoln Blue Water Classic and a few trips to the Cabbage Patch for tuna and sharks and another Broadbill trip with no success.

May and June we fished the ultra light challenge, mostly at the Cabbage Patch for tuna but the tuna where still small. This was my fishing Year for 2017-2018.

It was a cold, crisp and still May night when I launched the dingy in the Port River and headed toward Outer Harbour to catch some bait for the night.

The previous 23 trips were unsuccessful and the only thing keeping me going through this bad run was the thought that I was one trip closer to hooking a big Mulloway.



This year alone I had clocked up a tad over 300 hours total of fishing just in the river, between the months of February and May chasing Mulloway.

Within an hour I had managed to get enough live baits in the tank for the night and headed to the area I wanted to fish.

There was a boat anchored in the vicinity I was wanting to fish and they looked like they had settled in for the night, so I chose another spot that was approximately 150m away on another nice channel edge.

I lowered two live baits into the water and decided to get a couple of hours sleep on the incoming tide before waking for the turn of the tide on sunrise.

At around 4:30am I was woken by the sound of another boat going past me. The night was fairly quiet apart from a couple of Port Jackson sharks which had killed two of my live baits.

I then noticed the area I was originally wanting to fish was now free, so I decided to make a move.

Settled in my preferred location, I lowered down two fresh live baits, a live squid and a large live Salmon. Just as I got back into my swag I noticed one of the rods began to load up as a fish took the rod with the live Salmon.

I struck and set the hooks. The fish made a powerful long run into the middle of the channel and upriver. In the distance I noticed a tug boat heading in my direction. I couldn't turn the fish so I continued to play it out in the middle of the channel.

As the tug boat got closer he noticed I was in his path and gave me a couple of warnings sounds with his siren. At this stage I managed to turn the fish's head and it ran toward the shallows out of the channel.

Within 9 minutes of hooking the fish it began to tire and I got a glimpse of big silver flanks down in the murky depths. It then made a couple of last attempts to get away but I had it subdued on 24kg tackle.

The fish then popped up beside the boat in the darkness and I managed to slip the gaff into its mouth and lift the fish over the gunwales.




It was at this point I that I realised the actual size of the fish; a personal best for me in the Port River.

I knew it would be close to the Australian record for the 24kg line class which was held at 25kg.

I decided to get out the scales and weigh it, the scales hit just over 24kg with the tail still on the floor of the boat.

I knew it would easily go over 25kg when weighed properly on land.

Most Mulloway I capture are released after a couple of quick photos, but this one was coming back with me.



I got on the phone and called the clubs weight recorder Ash North who I ended up waking at 5:15am and excitedly told him the news. I then met me Ash at the ramp just as the sun started to rise over the Adelaide Hills, after he had collected the scales from the game club.

We hung the fish on the scales and it hit 28kg and measured 152cm in length.

After getting all the necessary photos and measurements we filled out the application form and submitted it for the

South Australia and Australian record.



I would like to thank Ash for his assistance, he was great and very helpful know exactly what had to be done, not many people would get out of bed 5:00am and drive all the way to outer harbour just to weigh a fish, thanks again Ash for you help.

Once all the paper work was done I took the fish straight to my mate Adam at "Immortal Fish" to have the fish moulded.


Within 5 weeks, Steve Morris the clubs technical advisor contacted me with the news that I had secured both the South Australian and Australian records.

This was a goal of mine which I had set and been chasing for the past 2 years in the Port River.

The fish replica was then completed a week later and is now hanging proudly on the living room wall as a reminder of that night and that persistence in fishing definitely pays off.







# NEW CONSTITUTION Updated 29/12/2017

#### 1. NAME.

The name of the Club shall be The Game Fishing Club of South Australia Incorporated (herein after referred to as "the Club")

#### 2. OBJECTS.

- (A) To promote the sport of game fishing both as a recreation and as a potential source of scientific data for the use and benefit of mankind, and to formulate and support fair, uniform and ethical angling rules.
- (B) To encourage and further the study of recreational angling, the related fish species and the habitat requirements of such species. To develop and support fish tagging programs and other sources of scientific data collection.
- (C) To affiliate or co-operate with "The South Australian Game Fishing Association", "The Game Fishing Association of Australia" and "The International Game Fish Association", as well as other bodies having interests complimentary to the Objects of the Club, and to support The Australian Fishing Museum.
- (D) In the absence of a State Branch of the Game Fishing Association of Australia, to govern and co-ordinate the sport of game fishing in South Australia, and to grant South Australian Game Fishing Records.
- (E) In the absence of a State Branch of the Game Fishing Association of Australia, to maintain a record of game fish and sharks caught or tagged in South Australian waters by Members and to submit claims for Australian and World Record captures on behalf of Members.
- (F) To promote game fishing tournaments in South Australian waters, instructional and social activities among Members, and to maintain historical records of the activities of the Club and its Members.
- (G) To acquire hold or deal with in any manner both real and personal property for the purposes of the Club.
- (H) To raise funds by subscription or otherwise in order to carry out the objects and interests of the Club.
- (I) To do all such acts and things as may be necessary to carry out the above objects.

#### 3. MEMBERSHIP.

The Club shall consist of Members who support and actively adhere to the Constitution of the Game Fishing Club of South Australia, in the following classes;

(A) Life Members (B) Junior Members (C) Family Members (D) Honorary Members

(E) Senior Members (F) Tournament Membership

#### 4. LIFE MEMBERS.

- (A) The Committee may recommend to a General Meeting of the Club that a Member who has rendered long and exceptional service to the Club be appointed a Life Member.
- (B) A candidate for Life Membership shall be elected by a majority of two thirds of the votes cast by the Members present at such General Meeting.
- (C) Life Members shall be entitled to all the privileges of Membership but they shall not be required to pay an annual subscription.

#### 5. ELECTION OF MEMBERS.

- (A) Every candidate for Membership of the Club shall be proposed by one Member and seconded by another. Either Proposer or Seconder shall have known the applicant for at least twelve months provided that, in special circumstances, the Committee shall have the power to waive this requirement. Every application for Membership shall be in writing, on the Clubs nomination form giving the name, address and occupation of the candidate, and shall be signed by all three.
- (B) Every application for Membership shall be submitted to the Committee promptly and all elections for Membership shall be by vote to be conducted in such manner as the Committee Chairman shall determine. Every Committeeman present may vote and more than one dissentient vote shall exclude.
- (C) A candidate shall become a Member upon election and payment of the prescribed entrance fee and subscription. The Secretary shall give prompt written advice of acceptance to the Member and record the name and address in the Register of Members.

#### 5.1. TOURNAMENT MEMBERS.

- (A) Tournament Membership is granted to non Members only for the duration of a specifically nominated tournament by the committee.
- (B) The fee applicable for the Tournament Membership will be nominated by the committee prior to the specific tournament nominated.
- (C) Any point score accrued by the Tournament Member during the tournament will count for that specifically nominated tournament only. Points accrued when fishing on a full Member's boat will also only count for that specifically nominated tournament and not count towards the full Members yearly boat point score



#### 6. JUNIOR MEMBERS.

Junior Members are Members who have not attained the age of sixteen years and have been elected and made prescribed payments in accordance with (Clause 5).

#### 7. FAMILY MEMBERS.

The partner and/or children of a Member shall be eligible for Family Membership upon payment of the prescribed subscription.

#### 8. HONORARY MEMBERS.

- (A) Criteria: Honorary Membership is only to be issued to a person who has proven to have given prolonged unselfish support and/or assistance by their actions or interactions with or for the Club and whose Honorary Membership been agreed and ratified to by the Committee as stipulated in the nomination process (as detailed in sub clauses B & C herein).
- (B) Honorary Membership may be granted by the president or by any two Members of the Committee to any person with or without the payment of any entrance fee or subscription.
- (C) The name of any Honorary Member so appointed shall be reported to the next meeting of the Committee.
- (D) The Committee shall have the power to cancel the Honorary Membership of any person at anytime and without assigning and reason therefore.
- (E) Honorary Members shall not be eligible to vote or hold office within the Club.
- (F) The Committee, at its discretion, shall appoint a Club Patron.
- (G) Honorary Members will be allowed fishing rights at no cost to them and the Club will bear the costs of those GFAA Affiliation fishing rights fees.

#### 9. SUBSCRIPTION.

The Club's year shall commence on the first day of July in each year. The amount of the entrance fee and annual subscriptions to the Club shall be determined by the Committee. All annual subscriptions shall become due on the first day of July in each year and be payable before the thirty-first day of July of the same year.

#### 10. SUBSCRIPTIONS IN ARREARS.

If the annual subscription of a Member shall remain unpaid after the thirty-first day of July, the Member, after notice thereof, shall have been sent to him by the Secretary, may have his Membership terminated by resolution of the Committee and his name removed from the Register of Members.

#### 11. ADDRESS OF MEMBERS.

Members shall advise the Secretary of any change of address and the Secretary shall register the same. All letters and notices posted and addressed to the last registered address of a Member shall be deemed to have been served within forty eight hours after posting and to have been properly addressed.

#### 12. TERMINATION OF MEMBERSHIP.

- (A) A Member may retire from Membership of the Club at any time by giving the Secretary notice in writing but any Member retiring without having paid subscription for the then current year shall be liable for the same.
- (B) If any Member shall refuse or neglect to comply with the provisions of the Constitution of the Club, or if any Member shall, in the opinion of the Committee be guilty of any conduct deemed to be prejudicial to the interests of the Club, or the sport of game fishing, such Member may be expelled by resolution of the Committee, provided that at least one week before the meeting of the Committee, at which such resolution is to be moved, such Member shall have had notice of such resolution for his expulsion and he shall at such meeting and the passing of such resolution have an opportunity of giving orally or in writing any explanation or defense he may think fit.
- (C) Any person ceasing to be a Member of the Club shall forfeit all fees, rights in & claims upon the Club & its properties.

#### 13. COMMITTEE

- (A) The affairs and general business of the Club shall be managed by a Committee which shall consist of a President, Secretary, Treasurer, and Weight Recorder, Technical Advisor and Five Members or Life Members of the Club.
- (B) The committee shall be elected at the Annual General meeting of the Club each year in the manner prescribed in paragraph 15 of this Constitution.
- (C) Meetings of the Committee may be convened by either the President or the Secretary, and shall be convened at the request of any two Committee Members.
- (D) The President shall preside at all Committee Meetings or if he is absent from the Meeting the Members may choose one of their number to be Chairman of the Meeting.
- (E) A quorum shall consist of not less than four Members of the Committee.
- (F) Any casual vacancy on the Committee may be filled from among the remaining Members of the Committee.
- (G) In regard to charges made of the behavior breaching the Club's Harassment & Bullying policy.



The President will appoint three Committee Members to investigate the charges, report findings & recommend possible actions for consideration of the full Committee.

- (H) Possible Committee actions by the majority, in regard to a proven breach of the Club's Harassment & Bullying Policy
- 1/ Verbal apology.
- 2/ A Public written apology.
- 3/ Damages, Fines & or costs
- 4/ Temporary suspension of Membership
- 5/ Termination of Membership forfeiting all fees, rights in & claims upon the Club and its properties

#### MEMBERS OF THE CLUB

#### 14. HARASSMENT AND BULLYING

#### (A) Aim

- a. The Club aims to eliminate the risk of injury to its Members and other persons by putting in place a planned and systematic approach to bullying and harassment.
- b. Harassment and/or bullying and/or victimisation in any form including online behavior, is not tolerated by the Club. This policy is in place to ensure that any incidents of harassment or bullying can be identified, reported, responded to and resolved as soon as possible.

#### (B) Scope

- a. This policy relates to all Members participating in any of the Club's activities at its premises or any other site where related activities are held, or social gatherings of the Club occur, or online through any form of social media.
- b. This policy should be read in conjunction with the constitution of the Club.

#### (C) Definitions

- a. **Victimisation** is unfairly treating people for complaining or helping others to complain, either within the Club or to the Equal Opportunities Commission or other like bodies. Unlawful victimisation is unfair treatment for complaints about discrimination or sexual harassment.
- b. Repeated in this context refers to the persistent nature of the behavior and can refer to a range of behaviors that occur over time.
- c. Unreasonable Behavior refers to behavior both real-life and online, that a reasonable person, having regards for the circumstances, would see as victimizing, humiliating, intimidating, undermining or threatening. Legitimate comment on any Club related activity or performance is not unreasonable behavior.
- d. **Discrimination** is treating a person less favorably than another person because of their race, colour, national origin, sex, disability, religion, sexual orientation, or some other attribute or characteristic as specified under anti-discrimination or human rights legislation.
- e. Harassment is unwanted behavior that offends, humiliates, discriminates or intimidates a person.
- f. **Sexual Harassment** is sexual behavior which makes people feel offended, afraid or humiliated and in the circumstances, it is reasonable to feel that way.
- g. **Bullying** is repeated, unreasonable and unwelcome behavior directed towards a Member or group of Members that creates a risk to health and safety.

#### (D) Objectives

- a. Promote awareness of personal and others' health, safety and welfare and to promote a positive and healthy environment for Members and visitors of the Club.
- b. Consult with and encourage Members to contribute to the decision-making process on harassment and bullying.
- c. Establish guidelines for the management of any harassment and/or bullying complaints or concerns made.
- d. Ensure adequate systems are in place for the investigation of incidents and injuries arising in the Club.

#### (E) Roles and Responsibilities

Persons managing the affairs and general business of the Club ("the Club Committee") The Club Committee will ensure that: ......

#### **Members**

All Members are required to:

- ☐ Observe all instructions given by the Club Committee with regards to this policy;
- ☐ Ensure their behavior complies with the requirements of this policy;
- ☐ Report any/all incidents or hazards in the course of the Club's activities and meetings to the Club Committee;
- Derovide constructive feedback on any matters which may affect their health, safety and/or welfare relating to harassment and bullying;
- ☐ Keep confidential any matters arising from this policy other than with the Club Committee.

#### (F) General Requirements

The Club's policy is to provide an environment free from all forms of harassment, bullying and victimisation.

#### A. Bullying (in person or online)

- i. Examples of unreasonable behavior include, but are not limited to, abusive, insulting or offensive language or comments, unjustified criticism or complaints, deliberately excluding someone from Club activities, setting unreasonable timelines or constantly changing deadlines, spreading misinformation or malicious rumors and changing Club arrangements to deliberately inconvenience a particular Member or Members of the Club.
- ii. Legitimate comment on Club related behavior or comment is not unreasonable behavior and therefore does not constitute bullying. Full and frank feedback can be given in a sensitive and constructive manner.
- iii. Bullying can be both intentional and non-intentional. The test applied is whether the behavior could be reasonably held to create a risk to health and safety.
- iv. The Club takes seriously any allegations of bullying by a Member.
- v. Members are encouraged to balance the need for a light hearted environment with behaviors that can be considered bullying.
- vi. Any Member who is subjected to bullying should inform the Club Committee in writing.
- vii. Once notified of an incident of bullying the Club Committee will take the appropriate action.

#### **B. Sexual Harassment (in person or online)**

- i. Sexual harassment includes, but is not limited to, unwelcome touching or kissing, comments or jokes, leering or staring, sexual pictures, objects, emails, text messages or literature, direct or implied propositions or requests for dates and/or questions about sexual activity.
- ii. Sexual harassment is not mutual attraction or friendship with consent.
- iii. Any Member who is subjected to sexual harassment should tell the Club Committee.
- iv. Once notified of an incident of sexual harassment the Club Committee will take the appropriate action.

#### C. Discrimination (in person or online)

- i. A Member cannot be discriminated against as a result of them:
- ii. Wanting to be, or being, a Club Committee Member;
- iii. Performing any powers or functions under such a role;

#### D. Victimisation (in person or online)

- i. Under State and Commonwealth legislation it is unlawful to subject a person who has lodged a grievance of unlawful discrimination, workplace bullying, harassment or sexual harassment to victimisation.
- ii. Any Member who is subjected to victimisation should inform the Club Committee in writing.
- iii. Once notified of an incident of victimisation the Club Committee will take the appropriate action.

#### (G) Breaches of Harassment and Bullying Clause

- a. The Club expects that this policy will be complied with at all times. Breaches of this policy are taken seriously and are acted upon as considered appropriate by the Club Committee. The type and severity of the disciplinary action will depend upon the circumstances of the particular case and the seriousness of the breach.
- b. Any breaches of this policy, whether by the concerned Member themselves or by a third party should be brought to the attention of the Club Committee.
- c. Any complaints about policy breaches will be dealt with quickly, seriously and confidentially.
- d. If there is a risk to any Member's health or safety as a result of a breach of this policy then appropriate action will be taken at the discretion of the Club Committee.
- e. Malicious, vexatious or frivolous allegations of harassment or bullying that are unfounded will constitute a breach of this policy.

(H) Review of the Harassment and Bullying Policy

Review of the Harassment and Bullying Policy will be undertaken by the Club Committee regularly. All Members will be advised of agreed changes and arrangements made for their implementation.

#### 15. ELECTION OF THE COMMITTEE.

- (A) At each Annual General Meeting of the Club the whole of the Committee shall retire from office but Committeemen shall be eligible for re-election. The Committee to manage the affairs of the Club for the ensuing year shall be elected in the manner prescribed.
- (B) Each candidate for office on the Committee shall be nominated in writing by at least two financial Members of the Club and such be approved in writing by the candidate. Nominations shall be lodged with the Secretary not later than the fifteenth day of June in each year.
- (C) If the number of candidates duly nominated does not exceed the number required to be elected, the candidates nominated shall be declared elected at the Annual General Meeting, but if the number of candidates shall exceed the number required to be elected, a ballot shall be held at the Annual General Meeting and shall be conducted in such manner as the Chairman at that meeting shall decide.
- (D) Every Member of the Club present at the Annual General Meeting shall be entitled to vote for as many candidates as the are vacancies to be filled and no more. The candidates up to the number of vacancies who shall be declared elected and in the case of two or more candidates receiving an equal number of votes the Chairman shall have a second or casting vote.
- (E) If a ballot for the election of Members of the Committee is necessary at an Annual General Meeting, the notice convening such Meeting shall contain particulars of the offices to be filled and the names of the candidates for the same.

#### 16. ANNUAL GENERAL MEETING.

- (A) A general meeting of the Club termed the Annual General Meeting shall be held in the month of July each year at a time and place to be nominated by the Committee.
- (B) The business at the Annual General Meeting shall be the election of Members of the Committee, a report by the President, presentation of the Receipts and Expenditure for the year, the Balance Sheet of the Club and other business as my be permitted by the Constitution.
- (C) Any Member desirous of bringing forward any proposition or motion at the Annual General Meeting shall give written notice thereof to the Secretary by the fifteenth day of June of the year and the Secretary shall embody such proposition in the notice convening such Meeting, advice of which be posted to Members not less than fourteen days prior to the date of the Annual General Meeting.

#### 17. SPECIAL GENERAL MEETING.

The Committee may whenever they think fit, and they shall upon receipt of a requisition in writing under the hands of not fewer that twenty Members, convene a Special General Meeting of which at least seven days notice shall be given to all Members of the Club. Any requisition so made shall fully and clearly express the objects of the meeting so required to be called, and shall be delivered to the President or the Secretary. Under such circumstances the Committee shall forthwith convene a Special General Meeting to be held at such time and place as they shall think fit, not being more that twenty-one days after receipt of such requisition.

#### 18. CHAIRMAN.

- (A) The President shall preside as Chairman at every Annual General Meeting and Special Meeting of the Club.
- (B) If the President is not present or is unwilling to act, the senior Committeeman present shall preside as Chairman.

#### 19. QUORUM AT A GENERAL MEETING.

- (A) At any General Meeting of the Club, a quorum shall consist of twenty Members personally present and entitled to vote.
- (B) If within half an hour of the time for the Meeting a quorum is not present, the Meeting, if convened upon the requisition of Members, shall be dissolved.
- (C) In any other case it shall stand adjourned to the same day in the week at the same time and place, and if at such adjournment Meeting a quorum is not present within half an hour from the time appointed for the Meeting, the Members present and entitled to vote, shall be a quorum.



#### 20. VOTING AT A GENERAL MEETING.

- (A) Every Life Member and Member of the Club present at a General Meeting shall have a vote, and in the case of equality of votes, the Chairman shall have a second or casting vote.
- (B) Voting shall be decided by a show of hands unless a resolution is carried requesting a vote by ballot.
- (C) A declaration by the chairman that a resolution has been carried or lost shall be deemed conclusive evidence of the fact.
- (D) All resolutions carried at a General Meeting of the Club shall be conclusive and binding on all Members and no notice of motion to reconsider any such decision shall be received by the Committee during the current financial year ending on the thirtieth day of June.
- (E) Membership categories other than Life Members and Members shall not be entitled to vote.

#### 21. ALTERATION TO THE CONSTITUTION.

This Constitution may be added to or repealed or amended by resolution at any General Meeting of the Club provided that no such resolution shall have been deemed to have been passed unless it be carried by a majority of at least two thirds of the Members voting thereon, and rovided that notice of any proposed alteration at such Meeting shall have been given to the Secretary at least one month prior to such Meeting.

#### 22. FISHING RULES.

- (A) The Club recognizes The Game Fishing Association of Australia as the federal body controlling the sport of game fishing throughout Australia.
- (B) The Club recognizes The International Game Fish Association as the central body controlling the sport of game fishing throughout the world.
- (C) For the purposes of South Australian Records and for Club Tournaments the Committee may introduce additional classifications and local rules.

#### **23. AUDIT.**

The Committee shall appoint an Auditor to examine the records and accounts, the annual Statement of Receipts and Expenditure and the Balance Sheet of the Club. The Auditor shall report thereon at General Meetings.

#### 24. THE POWER.

#### 25. SEAL.

The Committee shall provide for safe custody of the Seal of the Club, which shall only be used by the authority of the Committee. Every instrument to which the Seal is affixed shall be signed by the president or Secretary and countersigned by a Member of the Committee. A record of every use of the Seal shall be noted in the Minutes of the next meeting of the Committee.

#### 26. INTERPRETATION.

The Committee shall be the sole authority for the interpretation of the Constitution and of any rules made there under, and the decision of the Committee upon any question of interpretation or upon matter affecting the Club and not provided for this Constitution or in the Rules made there under shall be final and binding upon Members of the Club.

#### 27. INDEMNITY.

The Members of the Committee shall be indemnified out of the funds of the Club from and against all charges, costs, losses, damages and expenses which they or any of them shall ore may incur or sustain in or about the execution of their respective offices.

#### 28. WINDING UP.

If upon the winding up or dissolution of the Club there remains after the satisfaction of all its debts and liabilities any property whatsoever, the same shall not be paid to or distributed among the Members of the Club but shall be given or transferred to some other club or institution having objects similar to the objects of the Club.

#### 29. DISTRIBUTION.

The Rules shall be printed on a copy thereof delivered to any Member upon election. They shall be binding upon every Member of the Club and no Member shall be absolved from the effect of these Rules on the allegation of not having received them.

# A QUICK LIVE BAIT READY PITCH SET UP

ost crews keep their pitch rods in the fighting chair or in the lowest rod holder on the tower, with the bait resting comfortably in a cooler or a bucket of water. During our last Marlin U in Costa Rica, I saw a great way to keep your coiled pitch bait leader tangle-free and ready for action.

The boys on the *Pipe*Layer came up with this tip
— I made just one minor
adjustment to make it
even easier. The crew



flossed a short section of plastic spiral wrap to the rod just below the reel and used it to hold the coiled-up leader from the pitch. When a fish came up to the teaser, you could just give the coil a tug and then let her eat.

I modified the rig by using a zip-tie instead of floss to secure the coil, making it easier to cut off and reattach as necessary.




